2020-2021 DRAFT SCHOOL YEAR CALENDAR

Background

The Draft School Year Calendar for 2020-2021 was developed as per the guidelines outlined in Regulation 304, School Year Calendar and Professional Activity Days. The calendar includes 194 school days, 7 professional activity days and 9 examination days for secondary schools. As this is a modified School Year Calendar, which means we would start before Labour Day, this calendar must be submitted to the Ministry of Education for approval before March 1, 2020.

The calendar was created by a committee representing the following five boards; Northwest Catholic DSB, Rainy River DSB, Kenora Catholic DSB, CSDC des Aurores boréales, and the Keewatin-Patricia DSB and is based on the following requirements:

- Adherence to the Education Act;
- A balanced number of days in each semester;
- · Shared bussing with coterminous Boards;
- · Scheduling of co-curricular activities; and
- Feedback from the School Year Calendar Survey

As part of the standard practice for developing the School Year calendar the committee asks for individuals to fill out the School Year Calendar survey to indicate their preference for; the start and end date of the school year, PA days on Mondays or Fridays, and any other additional comments they want to share. This year the Keewatin-Patricia DSB received 2196 responses to the survey of which 1121 were from parents/guardians, 611 from staff, 223 from students and 241 from community members. Of the 2196 responses, 1974 responses or 90.43% of the respondents indicated a preference to start before Labour Day.

In creating this calendar, all the Education Act requirements were met, as well as all feedback was reviewed and considered, and it is believed that the attached Modified School Year Calendar is the best option for the 2020-2021 School Year.

Recommendation

That the Draft 2020-2021 Modified School Year Calendar be approved by the Trustees of the Board to be submitted to the Ministry of Education before March 1, 2020.
